We also educate drivers, community leaders, and those charged with enforcing our traffic laws about the benefits of cycling and their role in ensuring easy, fun and safe bicycling for everyone. Efforts include Drive Safety Education Campaigns, Youth and Adult Bike Safety Trainings, and Community Leader Bike Safety Education.

ADVOCACY - Bike Easy builds public support through grassroots organizing and community dialogue to ensure that elected officials and decision-makers prioritize safe and accessible bicycling. Our advocacy interfaces with other important issues like walking safety, transit access, health equity affordable housing, green infrastructure, economic development for all, and more.
